- Certified Certificate of Admission as a conveyancer

- Letter from the Law society for a good standing as a member of the Law Society.
- Certified copy of the Fidelity Certificate.
- Directors should not be listed on the Register of Tender Defaulters.
- Company / business profile should be submitted.
